### Customer Profile

- An experienced CISO from a multinational digital services organization operating in 80+ countries worldwide
- Needed to standardize processes, determine security priorities across global business units and regional operations

### Challenge

To build out a security strategy, the organization brought in the new CISO to develop a global security program. Knowing that there were inconsistencies in the security program across the company, the CISO started looking at how to report findings while simultaneously building a roadmap and remediation plan. He discovered each regional operating unit was running its own security program, and any oversight was managed

through their GRC tool and compliance team. The regions lacked a formal security operations department and reporting was based on either self-assessment or narrowly defined client-risk assessments.

Although they were using the same consulting firm across the regions, and against the same NIST standards, data and success criteria from region to region was inconsistent. The CISO determined they needed a more systematic approach in order to hold themselves accountable to a roadmap and more consistent path of continuous improvement over time.

With new business unit expansions requiring FedRAMP certification, they standardized on the Blue Lava platform. The Blue Lava CMM proved to align well to FedRamp's rigorous framework and broader scope of security controls. As a result, the findings from the assessment helped their new business unit pass the FedRamp and Authorization to Operate (ATO) application.

## Solution

Building upon this success as a new standard for assessing their security operations globally, Blue Lava was rolled out to standardize on best practices for measurement and reporting geographically. With the Blue Lava platform, the CISO now had a consistent, scalable, and repeatable process across all regions. Each area security leader now reports up to the global CISO and is responsible for maintaining data and mitigation work specific for their respective region.

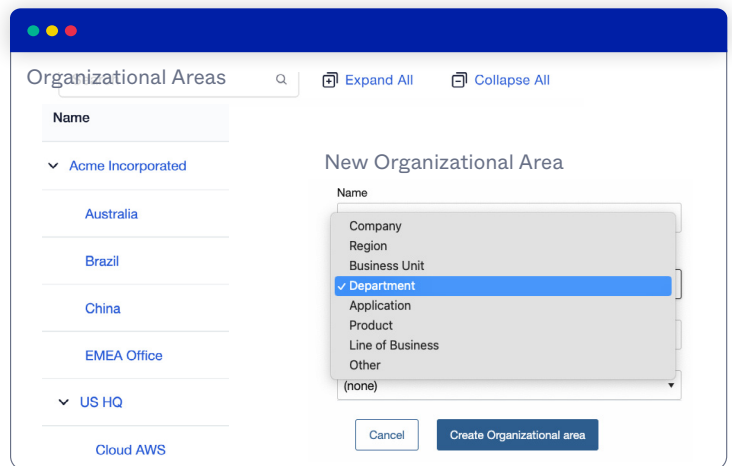
